On the basis of recommendations of the 1st District level Departmental Promotion Committee meeting held on 06-10-2023 and in pursuance to Government order No.69-JK(PDD) of 2024 dated 04-04-2024, followed by the instructions issued by the Administrative Department vide above referred communication and followed by the Managing Director KPDCL vide No.MD/KPDCL/Adm/F-1205-06 dated 18-05-2024 duly endorsed by the Chief Engineer (Distribution) KPDCL's No.CE/KPDCL/DPC/22278 Dated:06.06.2024 and after fulfillment of the parameters / criteria / document and receipt of the valid vigilance clearance certificate as per the procedure, the incumbents annexed as per annexure to this office order are hereby promoted as Lineman Grade 2nd in the pay level of (SL2 15900-50400) as per SRO-381 of 1981 dated 26-08-1981 strictly on the basis of their eligibility and in accordance with the seniority against the available vacant posts, with effect from 06.10.2023 (i.e. Date of DPC) monetarily from the issuance of this order and are posted /allotted to the Circles / offices shown against each. 
This Order is further subject to the fulfillment of following conditions:


1. That the incumbent(s) is holding genuine appointment in the Department and have not quit / resigned/ passed away or retired as on date.
2. That the work and conduct of the official(s) remained satisfactory, and there is no doubt about his Integrity.
3. That the incumbent(s) is not under suspension and are not involved in any Anti-National/ Subversive activity/ Criminal proceedings/Disciplinary action/FIR/embezzlement case pending against them in the court of law or any other agency.
4. That the incumbent(s) shall carry the pay scale in his personal capacity which he might have acquired prior to this functional promotion on the basis of "IN-SITU" promotion under SRO 14 of 1994 in view of clarification issued by the Finance Department vide OM No. A/29/96- 1034 dated: 22.01.1996.
5. That in case promote relinquish/forego/declines the functional promotion for reasons whatsoever, he/she shall have to forsake the benefit of "in-situ" promotion under rule 10 of SRO-14 of 1996.
6. That in case any incumbent who is otherwise senior / eligible for promotion by his name has not been included in this order shall represent to this office through proper channel within 21 days, along with documentary evidence, if the claim of the representee/senior found genuine, he/she shall be considered by demoting the junior one without giving any further notice. That in case no representation is received within the stipulated time, it shall be presumed that no senior eligible incumbent is left out.
7. That the inter-se-seniority of the incumbent(s) shall be strictly determined as per the provisions laid down in J&K CCA rules 1956.


