For and on behalf of the Managing Director, Kashmir Power Distribution Corporation Limited (KPDCL), Executive Engineer, Electric Central Workshop Division, Pampore (ECWD) Kashmir (here in after referred as 'Employer'), invites online e-bids from approved, reputed, Govt. approved Electrical Contractors/Labour Contractors having adequate workforce and machinery besides sufficient experience in carrying out similar nature of job (Store handling jobs) along with valid registration certificate for **Labour Rate Contract for Store handling such as loading, un-loading and stacking of Damaged/Repaired/Fresh Distribution Transformers of different capacities ranging from 25KVA to 630KVA, besides other raw material viz Transformer Oil, Winding Wire Rolls etc. at Electric Central Workshop Division Pampore, KPDCL** for the period of One year (2026-27) from the issuance of LOA or till finalization of next rate contract

1. The bidders need to submit the proof / cost of e-Bid document as stated in the above table through treasury Challan/ DD (non-refundable) from any Nationalized / Scheduled Bank pledged in favour of Executive Engineer, Electric Central Workshop Division, Pampore (ECWD) payable at Srinagar.

2. All the e-Bids must be accompanied by the scanned copy of EMD in the form of CDR/FDR/Bank Guarantee for tender participation, pledged to the **Executive Engineer, Central Workshop Division Pampore**. No Interest would be payable on Earnest Money deposited with the Department. The scanned copy of the T.R/Demand Draft and EMD must be uploaded along with the e-Bids.
3. **The original T.R/ Demand draft shall be submitted in a separate envelope to the Office of the Executive Engineer, Electric Central Workshop Division, Pampore, and should reach at least two day before opening of commercial and technical e-Bid (before 18th July), otherwise e-bid will be rejected in Techno-scommercial e-bids. Besides scanned copy of the Demand Draft must be uploaded along with the e-Bids.**

The e-Bids will be electronically opened in the presence of bidder's representatives, who choose to attend at the identified venue on indicated date and time mentioned in the above table or any subsequent day to the convenience of the Tender Opening Committee. An authority letter of bidder's representative will be required to be produced.

4. Bidders must quote **FOR ALL THE ITEMS** in the price schedule/BOQ of financial bid. **The bids of Bidders who will not quote for any item in financial bid shall be liable to be rejected at the discretion of the Employer** keeping in view the interest of the KPDCL.
5. KPDCL reserves the right to cancel any or all the e-Bids/ the e-Bid process without assigning any reason thereof, if any major lapse/deviation is found. The decision of KPDCL will be final and binding.
6. In the event of date specified for e-Bids opening being declared a holiday/closed day for department's office, then the due date for opening of e-Bids shall be the following working day at the appointed time and place.
7. All the required documents excluding Price Schedule/BOQ should be uploaded by the e-Bidder electronically in the PDF format, whereas Price Schedule/BOQ should be uploaded electronically in the same BOQ sheet provided with the SBD.
8. To participate in e-bidding process, bidders have to get 'Digital Signature Certificate (DSC)' class as per Information Technology Act-2000, to participate in online bidding.
9. As per Finance Department Circular No. 01 (Adm) FD of 2025 Dated: 08-07-2025, "Every participating bidder/contractor has to mandatorily disclose the bank account number which is linked with their GSTIN at the time of bid submission. No payments shall be released by the Government Department/Agency to any other bank account except the one linked with the GST registered number of the successful bidder."
