1. The bidders need to submit the proof / cost of e-Bid document as stated in the above table through treasury Challan/ DD (non-refundable) from any Nationalized / Scheduled Bank pledged in favor of Executive Engineer, Electric Central Workshop Division, Pampore (ECWD) payable at Srinagar.

2. All the e-Bids must be accompanied by the scanned copy of EMD in the form of CDR/FDR/Bank Guarantee for tender participation, pledged to the **Executive Engineer, Central Workshop Division Pampore**. No Interest would be payable on Earnest Money deposited with the Department.
3. The e-Bids will be electronically opened in the presence of bidders / their representatives, who choose to attend at the identified venue on indicated date and time mentioned in the above table or any subsequent day to the convenience of the Tender Opening Committee. An authority letter of bidder's representative will be required to be produced.
4. Bidders must quote **FOR ALL THE ITEMS** in the Technical Bid and in the price schedule/BOQ of financial bid. **The bids of Bidders who will not quote for any item in financial bid shall be liable to be rejected at the discretion of the Purchaser** keeping in view the interest of the KPDCL.
5. KPDCL reserves the right to cancel any or all the e-Bids/ the e-Bid process without assigning any reason thereof, if any major lapse/deviation is found. The decision of KPDCL will be final and binding.
6. In the event of date specified for e-Bids opening being declared a holiday/closed day for department's office, then the due date for opening of e-Bids shall be the following working day at the appointed time and place.
7. All the required documents excluding Price Schedule/BOQ should be uploaded by the e-Bidder electronically in the PDF format, whereas Price Schedule/BOQ should be uploaded electronically in the same BOQ sheet provided with the SBD.
8. To participate in e-bidding process, bidders have to get 'Digital Signature Certificate (DSC)' class as per Information Technology Act-2000, to participate in online bidding.
9. As per Finance Department Circular No. 01 (Adm) FD of 2025 Dated: 08-07-2025, "Every participating bidder/contractor has to mandatorily disclose the bank account number which is linked with their GSTIN at the time of bid submission. No payments shall be released by the Government Department/Agency to any other bank account except the one linked with the GST registered number of the successful bidder."
