- Bids must be accompanied with cost of Tender document in shape of Non-Refundable Demand Draft and EMD in the shape of CDR/FDR pledged to the Executive Engineer STD-I, Bemina Srinagar.** The Date of Demand Draft and EMD should be between the date of start of bid and Bid Submission End date.
- The date and time of opening of Bids shall be notified on Web site **www.jktenders.gov.in** and conveyed to the bidders automatically through an e-mail message on their e-mail address. The bids of responsive bidders shall be opened online

on same Web Site in the office of **Executive Engineer STD-I, Bemina Srinagar** .The bids for the work shall remain valid for a period of 180 days from the date of opening of bids.

3. EMD in the shape of CDR/FDR in favour of the Executive Engineer STD-I, Bemina Srinagar.
4. The normal deposits (deducted at 10% from running bills) to be released after total completion of the work.
5. The Contractors are advised to visit the site and to be aware of the conditions for launching at site of work before quoting the rates.
6. The contractor shall also be responsible for any theft/ damage to any of the component at site and the cost of damage/ theft if any shall be deducted from the work done or CDR of the Contractor till completion of work and handing over.
7. The date and time of opening of bids shall be notified on web site <http://jktenders.gov.in>. This is conveyed to the qualified bidders automatically through an e-mail message on their e-mail address. The financial bids shall be opened accordingly online on the same web site at the office of the Executive Engineer, STD-I, Bemina, Srinagar.

The e-Bids will be electronically opened in the presence of bidder's representatives, who choose to attend at the identified venue on indicated date and time mentioned in the above table or any subsequent day to the convenience of the Tender Opening Committee. An authority letter of bidder's representative will be required to be produced.
